On Monday December 19, the death sentence for two Baluch political prisoners detained in Section 3 of Zahedan Prison was announced after two months of being in a state of limbo. These two prionsers were taken to the 2<sup>nd</sup> Branch of the Zahedan Revolutionary Court presided over by Mohammad Marzieh five days before and were tried without a lawyer. ### Psychologically ill prisoner tortured by guards

Prisoner Majid Keshvari, who is suffering from psychological problems and has tried to commit suicide a number of times because of his condition, was tortured last week. Burn marks and signs of beating are evident on his body. "Majid has always tried to commit suicide because of the harassment of guards. Even the prison psychiatrist has confirmed his poor mental health", a person close to this prisoner said. "On Thursday December 8, guards were informed that Majid was looking for a rope to commit suicide but did nothing. His family was also informed and called the prison psychiatrist but still no measures were taken to stop the suicide until he once again committed suicide", the person added. Majid Keshvari is one of the 12 suspects of the Qezelhesar Prison "uprising" in 2010. From the 12 prisoners sentenced to death, seven people were executed while five of the suspects' death sentences were lowered to prison terms. (Javaneha website – Dec. 17, 2016)


Prisoners in Dizel Abad Prison in Kermanshah are forced to stay in very cold temperatures several degrees below zero, which puts the prisoners in danger of illnesses. The prison facilities also lack heating systems.

During the day, prisoners are forced to leave their cells and go outdoors. They have to go outside after breakfast until lunch and again after lunch. This is while some prisoners are suffering from kidney problems and according to doctors, being exposed to the cold can be fatal for them. (Zandaniran weblog – Dec. 16, 2016)



### Urgent Action Update: Prisoner Of Conscience Targeted For Teacher Union Activities (Iran: UA 171/15) URGENT ACTION DECEMBER 13, 2016

Iranian teacher union activist Esmail Abdi, the Secretary General of the Iranian Teachers' Trade Association (ITTA), was arrested on 9 November and taken to Tehran's Evin Prison to begin serving a six-year prison sentence. He is a prisoner of conscience targeted solely for his peaceful trade union activities.

Six intelligence and security officials arrested teacher union activist Esmail (Ismail) Abdi, a high school maths teacher and the Secretary General of the Iranian Teachers' Trade Association (ITTA), at his house on 9 November 2016 and took him to Evin Prison to begin serving his six-year prison sentence. Amnesty International understands that the officials carrying out the arrest refused to provide identification documents or an arrest warrant. Esmail Abdi was sentenced to six years in prison in February 2016 after Branch 15 of the Revolutionary Court in Tehran convicted him of trumped-up national security offences including "spreading propaganda against the system" and "gathering and colluding to commit crimes against national security". The charges stem from his peaceful trade union activities, including associating with Education International, the world's largest federation of unions, and organizing peaceful demonstrations by teachers and members of the ITTA outside Iran's parliament in May 2015 in protest against the level of both the education budget and wages in the sector, both of which they considered low, and the imprisonment of teacher union activists. The sentence was upheld on appeal in October 2016.

Esmail Abdi was first arrested by Revolutionary Guard officials on 27 June 2015, following his attempt to obtain a visa to attend the 7th Education International World Congress in Ottawa, Canada, in July 2015. He was held in solitary confinement in Section 2A of Evin Prison, which is run by the Revolutionary



Guards, for 40 days, and then transferred to Sections 7 and 8 of Evin Prison, where he was held with prisoners convicted of ordinary crimes for 10 months in poor conditions. He was released on bail on 14 May 2016. His release came 14 days after he started a hunger strike in protest at the imprisonment of himself and other trade unionists and teachers on spurious national security charges; the repression of trade unionists' peaceful assemblies and strikes; the ban on independently organized events for International Workers' Day and World Teachers' Day; and the continuing existence of wages that fall below the poverty line. In an open letter from inside prison in April 2016, Esmail Abdi wrote: "Going by the evidence used to issue the verdicts against [me], you could say that any effort... to improve the lives and livelihood of teachers and workers in Iran can be considered acting against national security". On December 18, prisoner of conscience Mohammad-Ali Taheri went unconscious on his 9<sup>th</sup> day of dry hunger strike, after more than 70 days of hunger strike. He regained conscience after being taken to the prison clinic and receiving serum and vitamins via injection.

He was denied the right to see his lawyer on December 17 after pressure by his interrogators. (Hesar News – Dec. 19,

Political prisoner Arash Sadeqi, who is on his 57<sup>th</sup> day of hunger strike, was denied the right to see his wife, Golrokh Iraie, for the second time. Security forces have threatened him saying that he would see his wife only after he dies.

Sadeqi has lost his speech and more than 18 kilos of weight. He constantly goes unconscious, suffers from kidney and respiratory problems, vomits clots of blood,

Iranian Revolutionary Guard officials have pressured British-Iranian charity worker Nazanin Zaghari Ratcliffe, a prisoner of conscience, to choose between moving her twoyear-old daughter into prison with her for up to three days a week or sign a document to say that she does not want the "right to be with her young daughter".

Prisoner of conscience Nazanin Zaghari Ratcliffe, a

British-Iranian charity worker held in Tehran's Evin Prison, told her husband on 25 November that Revolutionary Guard officials had pressured her to choose between moving her two-year-old daughter, Gabriella Ratcliffe, into Section 2A of Evin Prison with her for up to three days a week or sign a document to say that she does not want "the right to be with her young daughter". There are no suitable facilities for children inside Evin Prison. In her last phone call with her husband on 2 December, Nazanin Zaghari Ratcliffe said that neither choice is acceptable to her and what she requests from the authorities instead is more regular visits – either a day-long visit or two half-day visits each week – with her daughter. She is currently

allowed to have only one hour-long visit per week. The authorities seem to have imposed this choice in a misguided attempt to counter the negative publicity caused by the fact that she has been separated from her child. She has suffered a serious decline in her physical and mental health, and wrote a suicide letter to her husband in October.

Nazanin Zaghari Ratcliffe was sentenced to five years' imprisonment in September following an unfair trial before a Revolutionary Court in Tehran, which convicted her on trumped-up national security charges. The precise charges remain unknown to the family. Articles available on state-run news outlets indicate that her conviction solely stems from her professional work with media foundations and charities based in the UK. At the time of her arrest, which happened in April when she was on holiday in Iran, she was employed as a project manager for the Thomson Reuters Foundation (TRF), managing journalism and media training projects in countries including Lebanon, Jordan, Morocco and Myanmar and preparing fundraising applications. State-run news outlets have claimed that she was a "spy" for TRF and that TRF pursues the interests of Western states by promoting "Western-style" democracy in developing countries and facilitating, in turn, "the erosion of local cultures and traditions". Amnesty International understands that TRF has no projects on Iran. In June, the head of the justice department of Kerman Province stated that Nazanin Zaghari Ratcliffe had "conducted actions against the security of the country during the 2009 sedition [referring to the post-presidential election protests] through designing various websites and carrying out media campaigns". These accusations are solely based on the work that she did seven years ago in London as an administrative assistant at BBC Media Action for a project that trained youth journalists in Afghanistan and Iran.

Female political prisoner goes on hunger strike to demand violated rights

Political prisoner Lavin Karimi who is suffering from gastro hemorrhage started a hunger strike on December 21 in protest to not being taken to the hospital from Hamedan Prison and a decision by the prosecutor, which denies her a medical leave. She has not been allowed to go to the hospital despite the fact that the prison medic has stressed that she has to be hospitalized because of the hemorrhage.

This student from Saqez is suffering from gastro problems because of the torture inflicted on her during interrogations.

The 26-year-old management major was sentenced to three years of prison on charges of cooperating with dissident Kurd parties. (Human Rights in Iran – Dec. 22, 2016)

Majid Azarkish said that the average age of the detainees was 18 to 25 years old.
