#### Three people hanged in Rasht

Three prisoners detained in the Lakan Prison in the town of Rasht were hanged at dawn. Gilan's Chief Justice, Ahmad Siavosh, announced that a 38 year old man was hanged on charges of participating in narcotics possession.

"A 46 year old man was also hanged on the charge of possessing heroin. Another man, aged 37, was also hanged today in Rasht for the crime of heroin possession. He had no previous records", he added. (Iran Online state-run website – Apr. 15, 2017)

#### Prisoner hanged in Mashhad Prison

A 22 year old man detained in Mashhad Prison was hanged. He was charged with stabbing a 26 year old man in defense of his brother. The death sentence was carried out at dawn on April 16. He was identified only by his first name as Meghdad. (ROKNA state-run News Agency – Apr. 17, 2017)

### Two prisoners executed in Tabriz Prison

# 7 prisoners hanged in Rajaie Shahr Prison

# Two prisoners hanged in Shiraz and Bandar Abbas prisons; hand of prisoner amputated 10 days before execution

A prisoner in Shiraz's Adel Abad Prison who was charged with robbery and murder, had his hand amputated before being hanged. He was hanged on the dawn of Saturday April 18. The amputation, which was part of his sentence was carried out around 10 days before the execution.

He was identified as Hamid Moieni and was charged with killing a sister and brother in 2014 and stealing their gold.

According to other reports, another prisoner with drug related charges was hanged in the Bandar Abbas Central Prison on Sunday April 16. He was identified as 37 year old Mohammad Sajedin. (Human Rights in Iran – Apr. 18, 2017)

A young Baluch man was killed after security forces opened fire on his car in the Jalegh-Saravan road in Sistan and Baluchistan. He has been identified as 25 year old Abdolrahman Derazehi. According to informed sources he was in driving in the car with his cousin and did not have anything with him when security forces opened fire on them without prior warning.

The bullet hit him in the head and he died instantly. When the security forces realized that he had been killed, they immediately

The first deputy of Iran's Chief Justice cited criticism regarding a number of executions of criminals in a press conference.

"Recently in Bandar Abbas, two people identified as Behrouz Shirin Zaban and Mohammad Nourmalah were executed for carrying and moving narcotics", Mohseni Ejeie said.

"Or in Kerman two people identified as Abdulhamid Hossein Zehi and Faramarz Kohkan, who were active in a drug trafficking ring, were hanged... or in Karaj a person was sentenced to death for carrying drugs... what else can we do with these people except execute them?", he stressed.

"At any rate, we will act according to our laws... and will not show leniency", he added. (Fars state-run News Agency - Apr. 16, 2017)



#### Iran: Halt imminent execution of two men arrested as teenagers

The Iranian authorities must urgently stop the imminent execution of two long-time death row prisoners who were children at the time of their arrest, Amnesty International said today.

One of the men, Mehdi Bahlouli, is due to be executed tomorrow morning in Karaj's Raja'i Shahr Prison, after more than 15 years on death row. He was sentenced to death by a criminal court in Tehran in November 2001 for fatally stabbing a man during a fight. He was 17 at the time of the crime.



The execution of the second man, Peyman Barandah, is scheduled to take place just three weeks later, on 10 May, in Shiraz Central Prison, Fars Province. He was arrested at the age of 16 and spent nearly five years on death row, after being convicted in August 2012, also for stabbing a teenager to death during a fight. "Carrying out the executions of these two young men would be an outrageous breach of international human rights law that would cement Iran's position as one of the world's top executors of juvenile offenders," said Philip Luther, Amnesty International's Research and Advocacy Director for the Middle East and North Africa.

"Mehdi Bahlouli has spent his entire young adult life on death row. His shocking ordeal epitomizes the cruelty of Iran's juvenile justice system which regularly sentences juvenile offenders to death in violation of international human rights law and then subjects them to prolonged periods on death row. The anguish and torment of living their lives in the shadow of the gallows also amounts to cruel and inhuman treatment."

Carrying out the executions of these two young men would be an outrageous breach of international human rights law that would cement Iran's position as one of the world's top executors of juvenile offenders

#### Man sentenced to prison and lashing



### Six men sentenced to flogging for theft

The members of a robbery network who had robbed the house of the wealthy son of a businessman were sentenced to prison, flogging and confiscation of property. Akbar, 25, Sadegh, 30, Amir, 24 and Nima, 22 were found guilty of robbery, while Saied was found guilty of complicity in robbery. Forty five year old Iraj was found guilty of buying the stolen goods. Sadegh and Amir were each sentenced to 4.5 years of prison and 74 lashes while Nima was sentenced to three years of prison and 74 lashes. Saied was sentenced to six months of prison and 10 lashes and Iraj was sentenced to three years of prison and 74 lashes. (ROKNA state-run News Agency – Apr. 19, 2017)

# Security forces attack private party in Isfahan

On Thursday afternoon, Khaled Chayan, 35, was also arrested by Revolutionary Guards Corps Intelligence Forces.

On Friday, two other men identified as 37 year old Khalil Ghafeli and 38 year old Mostafa Savari were arrested by intelligence agents.

"The number of deceased people as a result of work place accidents has raised 28 percent compared to the year before", Massoud Ghadi Pasha said.

Eight Baha'i citizens arrested in Iran



# Head of Guardian Council demands candidate disqualification of religious minorities for upcoming city council elections
