# Young prisoner executed in Bushehr

Ali Kazemi, a child-offender who committed murder at the age of 15, was executed in the Central Prison of Bushehr on the morning of January 30. Ali Kazemi was 22 when he was executed. This execution has not been announced by the official media up till now. (Iran Human Rights – Jan 30, 2018)

# At least two prisoners hanged in North-Western Iran

According to a source, on the morning of Sunday, January 28, at least two prisoners were executed at Orumieh Central Prison (Darya). The prisoners were sentenced to death on murder charges. # Iran: Authorities execute man in exceptionally cruel circumstances

Amnesty International is outraged by reports that the Iranian authorities have executed a young man convicted of murder who was only 15 years old at the

time of the crime.

The organization learned that 22-year-old Ali Kazemi was hanged earlier today in a prison in Bushehr province. His execution was scheduled and carried out without any notice given to Ali Kazemi's lawyer as required by Iranian law.

"By carrying out this unlawful execution, Iran is effectively declaring that it wishes to maintain the country's shameful status as one of the world's leading executers of



those who were children at the time of their crime," said Magdalena Mughrabi, Amnesty International's Middle East and North Africa Deputy Director. (Amnesty International)

On the morning of January 31, a 29 year old man identified as Abbas Rad was hanged in Yasouj. He was wounded on December 18, 2015 after he was shot and was then arrested by security forces.

In an attack to his place of residence, the locals and women were also beaten by security forces.

# 3 minor offenders hanged in Iran including young bride

The Judiciary of the Islamic republic of Iran hanged two minor offenders in one day on Tuesday January 30. The last minor to be hanged was identified as Mahboubeh Mofidi.

She was hanged in Noshahr Prison on charges of killing her husband when she was 17.

This is the third execution of a minor in one month in Iran. Prior to this, there were reports on the execution of Ali Kazemi and Amir Hossein Pourjafar who were 15 and 16 when they committed murder. The execution of Mahboubeh and Ali have not been published by state-run media.

There are at least 80 minor offenders in Iran who have been sentenced to death. (Radio Zamaneh, Iran Human Rights Organization - Feb.1, 2018)

The Marzan Abad Judiciary in Chalus, located in the Chalus-Tehran Road is used as torture center for detained protesters. According to a local source, there is a two story building in this road. The first floor is the Natural Resources Office while the second floor houses the Judiciary. Agents brought protest detainees from various Iranian cities to this building, where they were

subjected to severe torture. According to reports, a young protester Ali Pouladi who was brought to this center died under torture. He was arrested on January 12. (Political Prisoners Alliance – Jan. 25, 2018)

Six political prisoners identified as Mohammad Saleh Shahdadzehi, 30 year old Farooq Anvari, 40-year-old Idris Jamshidzehi, 30-year-old Abdolaziz Sotvan, 27-year-old Mahmoud Sotvan, and 28-year-old Hashem Zardkouhi who is a former bank employee were transferred to Zahedan Prison after nine months of torture at a detention center run by the Ministry of Intelligence.

The political prisoners were arrested in June 2017 in Iranshahr.

According to an informed source, the prisoners were subjected to various tortures, including de-nailing (pulling out their fingernails) and flagellation on their body and soles of their feet during their nine months of detention. (Baluch Activists Campaign – Feb. 1, 2018)

# Young Baluch man shot and wounded by prisoners left paralyzed in prison

Twenty one year old Baluch prisoner, Jasem Baluchi, was shot in the spinal cord by security forces and has become paralyzed from his waist down. Despite this, he has been left without necessary medical attention in Saravan Prison. An informed source said that agents ordered him to stop his car suspecting him of carrying drugs.

"He stopped and came out of his car, but despite not having anything with him, the agents shot him three times. They then detained him", the source added.

"His family have gone to the prosecutor numerous times to request that he receive medical attention, but the head of the Judiciary and Prosecutor have not accepted", the source said. (Baluch Activists Campaign – Jan. 26, 2018)

# Hunger striking political prisoner severely beaten and transferred to Greater Tehran Prison

On Monday, January 29, political prisoner Soheil Arabi was transferred to the Greater Tehran Prison and was severely beaten. According to an informed source, on January 28, Soheil Arabi was summoned and was then transferred to the quarantine in Evin Prison's Section 1. "He was then summoned again and told that he would be

transferred to Rajaie Shahr Prison. But at noon, instead of being taken to Rajaie Shahr, he was taken to the Greater Tehran Prions", the source said. "When they reached the prison at 15:30, prison officials along with 10-12 soldiers tore off his clothes and severely beat him. The guards used batons and kicked him in his back, face and leg continuously with their boots. Soheil Arabi's face, nose and feet were injured and his whole body was bruised", the source added.



After the beatings, prison authorities kept him without clothes in the prison courtyard to force him to give his consent to those that beat him. "Don't think that this is Evin Prison and you aunties house!" a prison official taunted him. "This is the end of the world and hell! Don't think that because you're on hunger strike, your voice will be heard!" he told him. (Zandaniran – Jan. 30, 2018)

#### Family of political prisoner threatened not to follow up son's prison leave

Following a request from the father of political prisoner Maher Ka'bi from the Shush district court for a prison leave for his son, the Intelligence Agency called the family threatening them not to follow up such a request.



"Are we supposed to send your son to a hotel?!" agents said, taunting the family. This is while the political prisoner has been imprisoned in Ardebil, which is far away from his home. He is detained in a very isolated section with minimum facilities. Maher, who is now 25 years old, was arrested at 19. He was charged with acting against national security and being a member of the Ahwaz Liberation Organization and was sentenced to 10 years of prison in exile. According to those close to him, he was not affiliated with any organization. His brother Ahmed Ka'bi is also detained in Kerman Prison. The two brothers were severely tortured when arrested. The tortures have led to severe back problems for Ahmad, to the extent that he cannot stand on his legs for even 10 minutes. (Political Prisoners Alliance – Jan. 30, 2018)

# Ailing political prisoner denied medical treatment in Ardebil Prison

Political prisoner Mohammad Saber Malek Reiesi, who is detained in Ardebil Central Prison is suffering from medical problems including digestive issues as a result of a long term hunger strike. Prison officials refuse to provide medical treatment despite his condition.

The medical ban is such that even when he was allowed

to see the clinic medic, the prison doctor told him that he would not visit him. "You could have not gone on hunger strike and you should have thought about the consequences before your strike", the doctor told him.



Mohammad Saber Malek Reiesi lost about 24 kilos after going on hunger strike for 39 days in protest to limitations and pressures imposed on him by prison officials and being beaten. (Human Rights Activists in Iran – Jan. 31, 2018)

According to an informed source, the site of the arrest of the men is under siege by security forces. There is no further information on the fate of the detainees. these two students have still not be released for unknown reasons", an informed source said. "The judge handling their case has told their family that they were ordered to keep students who have not been released until their cases were seen to", the source added. # Head of Prison Organization gives report on protest detainees

Alireza Rahimi, a member of the National Security and Foreign Policy Commission in the Majlis wrote a memo about the visit of a Majlis delegation to Evin Prison.

The memo reads in part:

"Before the visit, the head of the Prisons Organization, while announcing the statistics related to the January incidents (protests), said:



The total number of prisoners in January was 4,972, 73.94% of whom were male and 27.5% of whom were women.

50percent of the detainees were between 19 to 25 years old and 27% were between 25 and 32 years old.

Of the total number of detainees, 4,534 were released and 438 are still in detention. In addition, 55 people are detained in detention centers run by the Ministry of Intelligence.

The remaining detainees are in the provinces of Hamedan, Khuzestan, Fars, Isfahan and Tehran.

A total of four men and two women from Tehran are in temporary custody.

Two of the detainees in Tehran are in custody of the Ministry of Intelligence. (Mazand Majlis state-run Website - Feb. 2, 2018)

# Activists arrested by security forces in Iran

Security forces arrested a number of civil rights and human rights activists today in a coordinated measure. Some of these activists are Saied Eghbali, Behnam Mousivand, Mahmoud Massoumi, Shima Babaie and Dariush Zand.

Security guards posed as post office employees to get inside the home of activist couple Shima Babaie and Dariush Zand and arrested them. According to other reports, a source close to Saied Eghbali said that he was arrested and transferred to an unknown location while visiting his ailing father in Kangavar. Cyber police encountered a social media channel, active under the name of a cultural channel, while the channel content had nothing to do with culture. The suspect, who was 32 years old and married, was arrested, and his case was referred to the judiciary. He was sentenced to four months of prison. (ROKNA state-run Website – Jan. 25, 2018)

There was no mention on where the man was arrested or details of his activities on social media.

At least four child victims of Kermanshah earthquake die from cold and unsuitable conditions



In recent days, several children and one infant died as a result of government failure to provide minimum facilities to earthquake stricken families in Kermanshah. One of the victims was 2 year old Sarina. She died after suffering a severe fever and seizures and not having warm shelter.

"Despite our request to receive a shelter, nothing was given to us. My daughter Sarina developed a severe cold and fever. Sarina's persistent seizures worsened her condition by the minute", Behrouz Zahabi, Sarina's father said.

"On January 17, Sarina's condition severely deteriorated and she passed out. Because of the lack of facilities at Sarpol Zahab Hospital and a lack of specialists, they could not do anything for my daughter and said that she had to be taken to Imam Reza Hospital in Kermanshah. The next day, I took her to that hospital but after two hours, my two year old died in my arms", he added. (Tasnim state-run News Agency - Jan. 24, 2018)

The second victim was 4-month-old Mohammad. He froze to death in Kermanshah.

"After the earthquake in Kermanshah, our house was completely destroyed and we lived in a tent given to us by other people", his father Abdullah Seifouri, said.

"Due to the extreme cold in the tent, Mohammad developed a cold. We went to the relevant

authorities to give us shelter but they said no. Mohammad got worse on January 5 and was hospitalized until January 13. He left us forever on January 13. This has been a great shock for his mother", He added. (Tasnim state-run News Agency - Jan. 26, 2018)

I took my child to a specialist in Kermanshah... The doctors came to see him and after a few minutes he started breathing and they said that he was fine... #### Prisoner sentenced to reading religious book

The court advocates sentenced him to three years of suspended prison in accordance to the offender's conditions including not having a criminal record, repenting, getting the complainants agreement not to press charges, cooperating with the investigation and having economic problems.

After providing and studying the book, the accused has to report to the Implementation Department of the Penal Court every six months on how he read the book, how much he read and the results of reading the book. He also has to provide a summary of the book in his own handwriting.

After the end of the second six month report, an exam will be held under the auspices of the Cultural Justice Department and if he passes the test, the assignment will be completed. If he does not pass, the assignment will continue until he passes. (ROKNA state-run Website - Feb. 1, 2018)

TEHRAN — Climbing atop a five-foot-tall utility box in one of Tehran's busiest squares on Monday, an Iranian woman removed her head scarf, tied it to a stick and waved it for all to see. It was no small feat in Iran, where women can be arrested for publicly flouting the Islamic requirement that they cover their hair. But there she stood, her curly hair blowing in the breeze. No one protested. In fact, she was applauded by many people. Taxi drivers and older women took her picture.

"My hands were trembling," the 28-year-old



said, asking not to be named out of fear of arrest. "I was anxious and feeling powerful at the same time. And proud, I felt proud."

She was not alone. On Monday several other women, a total of six, according to social media accounts, made the same symbolic gesture:

At least one of the women protesting on Monday was arrested by the police, a shopkeeper who witnessed the arrest said.

And some said this might just be the beginning. "My guess is that more of these protests will follow," said Nasrin Sotoudeh, a lawyer and human rights activist. "It's obvious that some women want to decide for themselves what to wear."

The Islamic head scarf, or hijab, is seen by Iranian ideologues as a pillar of the Islamic Republic of Iran. The law regarding the scarf has been enforced since the 1979 Islamic Revolution, and a head scarf is obligatory for every woman in the country, even tourists and visiting foreign dignitaries.
