Younes Hosseini, Public and Revolution prosecutor of capital of Mazandaran Province (north of Iran) informed about the nemesis of a person alleged to murder in the yard of Babol Prison: "The convict A-F, son of Sheidollah was hanged in the yard of Babol Prison in presence of the victim's family. The decree was carried out after it was issued by the province's penal court, endorsed by the Supreme Court and permitted by the head of judiciary". (ILNA state-run News Agency- May 5, 2018)

#### Prisoner Executed at Rajaee-Shahr Prison in Karaj

On Wednesday morning, May 9, 2018, a prisoner was executed at Rajaee-Shahr Prison in Karaj. The prisoner convicted of intentional murder and sentenced to execution (nemesis) is identified as "Reza Hamidi". Reza was transferred from ward ten of this prison to solitary confinement on May 7th.

An informed source said: "Reza was condemned to execution for killing his motherin-law. He wasn't able to gain the forgiveness of those who complained till the last moment". This execution is not announced by Iran's media up to the publishing of this news. (Human Rights Organization - May 9, 2018)

The third-in-row culprit, who was

Parviz Zare Zehi, citizen of Khash Township (southeast of Iran) was killed by the direct shooting of Relief Unit agents on Tuesday, May 8, 2018.

The agents left the scene after shooting.

During the last 17 months this is the 70th Baluch killed by Disciplinary agents.

There has been no positive reaction so far from the officials to solve this acute problem and the report of killings is censored in internal media. (Baloch Activists Campaign- May8, 2018)

#### Two Border Porters Wounded in Border Regions

A group of border porters at zero border point were raided at by border patrol. Being chased by these patrols Naser Nojavan fell off the height and was severely injured in neck and head. Naser was transferred to Orumieh medical centers and his is reported to be in dire condition.

On May 5, 2018 a border porter from Piranshar Township, Rahman Tafakhor, 45 years old, was directly shot at by border patrols in Kani Khoda Heights and was wounded in leg. (Human Rights Activists in Iran- May 8, 2018)

Last night Saravan (in Systan & Baluchistan Province) police shot at a vehicle carrying 4 bags of rice and killed a Baloch youth. He is not identified yet. Clip received from eye witnesses show that people protest the act and police forces are preventing them from taping the scene. During the last 17 months this is the 71st Baloch who has been killed or wounded in the shooting by Disciplinary agents. Last month in such a shooting at a vehicle with Afghan immigrants as passengers, 19 people were killed ann wounded. (Baloch Activists Campaign-May 20, 2018)

Nasrin Sotoodeh: 3 Times Execution of Mohammad Saleth to Evoke Fear and Horror

There is a trial going on for Mohammad Salath, one of the Dervishes who were arrested during the events of Feb.19, 2018 at Pasdaran St. (Tehran). The file was sent to the Supreme Court after the decree was

issued. One year imprisonment, 74 cable strokes and three times execution was endorsed.

In an interview regarding this case, Nasrin Sotoodeh, Jurist and lawyer said: "In criminal cases, usually it's the court that is responsible for the details of the case. This is a routine in all judiciary communities. But in the case of dervish Mohammd-Yavar Salath, the court has issued three times execution only in two sessions and with an unbelievable speed this verdict has been studied over and endorsed".

She added: "It seems that this sentence is for evoking fear and horror...". (Iran News Agency- April 30, 2018)

Jamiley Sadeghi, woman prisoner from Qarveh (in Kurdistan Province) jailed for 15 years in Sanandaj Central Prison has not been on any leave so far. An authentic source said that this woman was arrested in 2003 accused of murdering her husband. Jamileh was condemned to death after detention, by Qarveh Township's penal court and is on death row since then. (Hangaw- May 10, 2018)

Fazad Sahraee, arrested during national protests on January 2018 and arrested in the city of Qom started serving his two years imprisonment on Saturday May 5<sup>th</sup>.

He was arrested in front of his residence being beaten by security forces and after a few days of interrogation along with mayhem he was transferred to ward 12 of Langrood Prison. Being freed on bail he was eventually tried by judge Qhasemi at branch one of Qom Province's (socalled) Revolutionary Court in two session and only for few minutes.

It is to be mentioned that two other protesters; Ali Ebadi and Hassan Badi'I who were arrested at the same time but in different cases were condemned to 10 and 2 years imprisonment respectively. Due to act 134, known as assemblage of decrees 5 years of Mr. Ebadi's sentence will

Osman Ismaili, a Kurd labor activist from Saghez Township was transferred to the central prison of the township. This activist was arrested four days ago during the events of the Labor Day by intelligence forces.

On Tuesday May 1, 2018, plainclothes raided workers



who had gathered for celebrating the Labor Day at Chami Valikhan square, a place for construction workers. After a one hour clash Osman Ismaili and some others were arrested. The plainclothes also confiscated cell phones of some of the protesting workers. (Kurdpa-May 5, 2018)

At'hareh Nejadi, President's deputy in programing and coordinating women and family affairs said: "Based on visits we had from country's prison(s), w omen are not under proper conditions in jails. Unfortunately mothers who have committed unintentional crimes are in jail with their small children. Children who only remember life as inside the prison walls..."

About the average age of women according to her visits she said: "By the existing information, the average age was between 17 and 37. Of course there were also elderly women too." (IRNA state-run News Agency- May 5, 2018)

#### Detained Environmental Activists Visit Their Families in Presence of Security Agents

The families of Sam Rajabi, Nilofar Byani and Alireza Farhad-zadeh visited them at Evin Prison. These visits which were about 10 to 15 minutes were in presence of security agents. An informed but anonymous source said on Tuesday, May 8<sup>th</sup> that in the visit which was yesterday, Nilofar Byani, a wild life specialist was

not in good psychological condition. She was sad and nervous. In mid-January a group of environment activists: Homan Joekar, Amir Hossein Khaleghi, Sam Rajabi, Taher Ghadirian, Nilofar Byani, Sepideh Kashani, Morad Tauhbaz and Kavoos Seyyed Imami were arrested. Two weeks later judiciary officials announced that Kavoos Seyyed Imami has committed suicide at the prison. After a while, about a month and a half later, Hasan Raq, Aref Zare, Hasan Zare, Abdolreza Koohpaye and Alireza Farhad-zadeh, also environment activists were arrested too.The spokesmen of Judiciary and Tehran's prosecutor announced that these people are charged with espionage.

Kaveh Madani, the resigned deputy of Environment Organization who was also arrested with the first series of these activists from "Parsian Wild Life" institute for a

short time and was interrogated, left the country two months later on April 16<sup>th</sup> and posted a tweet announcing his resignation. (Zamaneh Radio- May 8,2018)

#### Political Prisoner Back to Cell without Receiving Medical Treatment

Hamidreza Amini, political prisoner, who was deployed to Farabi Hospital for his eye problem along with some other prisoners, was returned to the prison without receiving any treatment.

He suffers from weakness of vision and pain in his knees while in jail.

Hamid is known as Aryo-Barzan (an Iranian hero) in virtual space and was arrested at noon of Dec. 2,

2017 at his residence and was transferred to prison. He was interrogated at Evin Prison; he didn't cooperate with the agents and was exiled to Fashafooyeh Prison. (Iran News Agency- May 9, 2018)

#### 8 Detainees on Hunger Strike

It is for several days that eight people arrested in Khozestan's peaceful demonstrations have gone on hunger strike to protest prison's dire conditions and heavy bails.

They are: Adeh Obayavi-poor, 25; Mehdi Majdi Obaydavi, Bagher Obaydavi, Bashir Tamimi, Hamzeh Saedi, Mohammad Shakhi, Ali Shakhi and Ahmad Afri, 29. These people are from city of Hamidieh and are arrested because they are Sunnis. They have been kept in Shayban Prison in Ahwaz for 10 months under custody without their files being referred to court. Their detention is constantly extended. Prison officials told them and their families who followed their case, that "in case they continue their hunger strike they will be transferred to solitary confinement." It is to be mentioned that during the demonstration of Arab citizens in Khozestan that lasted several days, at least 500 people have been arrested amongst them kids between 11 to 15 years old. More than 250 of them have been transferred to Shayban Prison in Ahwaz.

They are all kept in a separate ward in 10 quarantine sections. Each section has seven cells and in each cell the prisoners are in harsh condition. They are deprived of having connection with other prisoners and are banned from any visit. (Monitoring Human Rights in Iran- May 9, 2018)

As each hour 50 people add to the crowd of prisoners, the head of Social Relief Association emphasized on replacement punishments to ease the consequences of accumulation of criminals in prisons. Pointing to the fact the each year between, 420 to 430 thousand criminals enter prisons, Hasan Mosavi Chalak added: "One of the new and positive changes in judicial systems in the world is that they don't sent people to prison for all kind of crimes. This is not a trend in our country..."

Before that he had cited that increase in number of prisoners is a sign of "deteriorating moral values". He has said: "15 million judicial files shows weakness of social morale in Iran".

As Islamic Republic's Prisons Organization had announced, the number of prisoners in Iran in year of 1395 (2016-2017) has been 224,000 and 70% of the prisoners were less than 40 years old.

On Monday April 16, 2018, Reza Mahboobi, deputy in social damage affairs of Iran Social Affairs Organization announced: "500,000 people enter Iran's prisons on yearly basis." As he put it 200,000 of them stay there. (ISNA state-run News Agency; Radio Zamaneh- May 11, 2018)

...Regarding the case, Judge Hasan Haydari, political and security deputy of prosecutor's office in the capital of Khorasan Razavi province said: "A person affiliated with the Monafeghin grouplet (PMOI in regime's words) was arrested in Mashhad".

"This person had the intention to infiltrate among different guilds just before the Laber Day and Teachers Week to organize anti security measures,"he added.

"The accused, 37 years old, who was under scrutiny from a while ago for having connection with the agents of terrorist Monafeghin was arrested based on judiciary order after the information were collected. He is in under interrogation," cited Haidari. (Kayhan state-run daily, IRNA state-run News Agency- May 7, 2018)

Chief Editors of Iran and Etamad daily were convicted by Tehran province's press jury by majority of votes, on charges of "publishing lies to perturb public opinion".

Ahmad Momeni Rad, the secretary of the jury cited: "The members of the media court's jury held Mohammad Fazeli, chief editor of Iran daily and Elyas Hazrati, the chief editor of Etemad daily as guilty and said that they didn't deserve any commutation."

The court was held in branch nine of the 1st penal court of Tehran province, judged by Mohammad Kashkooli. (Hamshahri Online state-run Web Site- May 6, 2018)

#### Telegram Activist Deprived of Medical Treatment

Aliraza Tavakoli who was active in Telegram and now jailed for two years, is deprived of medical treatment; though he is suffering from joint pains and pain in his intestine. The prison doesn't count itself responsible to provide the prisoners with advance medication and gives them no alternative either; eventually the prisoner does not receive the treatment he/she needs.

It is to be mentioned that Mr. Tavakoli, Mohammad Mohajer and Mohammad Mehdi Zaman Saleh, three Telegram activists were detained in 2016 and each were sentenced to 12 years imprisonment.

After they protested against the decree, the revision court applied act 134 of Islamic Punishment Law and the sentence for "insulting the sacred" was counted as the highest punishment for them and their sentence was reduced to five years. (Human Rights Activists in Iran- May 5, 2018)

Seyyed Tabib Taghizadeh, journalist and an official of Baztab Emroz news website was arrested in 2015 and eventually sentenced to two years postponed

imprisonment for having connections with dissident media. This journalist who received his final sentence in recent days has been cooperative with medias such as Payam-e-Azadegan, Tadbir News, Borana, Ebtekar and Golden Look monthly.

After he was arrested in 2015, he was transferred to ward 209 of Evin Prison and kept in solitary confinement for 36 days. This journalist with a long time background in this area is charged with "acting against national security through cooperating with dissident media. A source close to Mr. Tabibzadeh said: "Every court session was less than two minutes. The last session was on March while the sentence was read to him in person about ten days before that." #### Larijani Defended Telegram Blockage

The head of judiciary openly defended the blockage of Telegram. He admitted that Iranian regime's officials expect that this network would cooperate with them. IRNA state-run News Agency wrote on May 7, 2018:

On Monday Sadegh Larijani, the head of Judiciary talked about the recent blockage of Telegram in a meeting with high judiciary officials. He said: "Judiciary has taken step in favor of the people's rights in this regard and in other cases".

Describing the reason of this blockage he cited: "I won't enter political discussions in this case because I find it against the country's unity".

"We made contact with Telegram officials and asked them to help us in identifying the criminals and in introducing them to us, but we received none", added Larijani. Larijani continued: "About the blockage of Telegram we don't have any ratification endorsed by the Supreme Leader that would say do not block (network) messengers." A person using a cell phone messenger as disguise and having 3000 followers who published immoral subjects was identified in Astaneh-Ashrafieh Township (north of Iran) and was arrested.

Mohammad Khani the head of FATA (cyber police) in Gilan Province gave the news and said: "With technical and police force follow ups, the main manager of this messenger, a 25 years old male was identified. After getting necessary judicial permits he was arrested in a surprise attack in Astaneh-Ashrafieh Township and transferred to FATA police." (ISNA state-run News Agency- May 8, 2018)

Maedeh Shabani-nejad, a 15 years old high school student in Abadan who was arrested for activities in virtual networks in month of Bahman (Jauary- February) 2018 by the intelligence agents is kept in Ahwaz's Sepidar Prison.

After 3.5 months her health is deteriorating.

Though she is suffering from stomach bleeding she is pt. In addition to that, they repeat her detention period

deprived of medical treatment. In addition to that, they renew her detention period constantly.

It is said that her family cannot hire a lawyer for her or cannot commute between Abadan and Ahwaz to visit her and follow her case due to financial problems. Some of her relatives have been arrested along with her in Ahwaz for giving her refuge. (Her aunt) Mahnaz Amoori Faisali, and (her uncle) Mahmood Amoori are still in detention. Tehran's Teachers Guild Club, describing the event on Thursday in its statement said that the teachers didn't go out of the park as the police force requested but they suddenly encountered a raid by Plainclothes: "SSF and Plainclothes dragged the teachers on the street to suffocate their voice which sought justice and the face of women were covered with blood".

"Marriage of girls under 15 causes several problems; divorce and becoming widows intensifies these problems," added Salahshori.

She cited: "Marriage of girls in early years of their lives makes them to suddenly enter the life of grownups and they will not enjoy the education and skills needed for a life".

"Divorce statistic last year is the highest so far; 175,000. Divorcing in the early years of life has unpleasant consequences", Added Salahshori.

The head of women's fraction also said: "By the given statistics about 2.5 to five million single parent women exists in the country. Not having a job and lack of necessary services causes them many harms". (IRNA state-run News Agency- May 8, 2018)
