On Tuesday morning, May 29, 2018, the Iranian armed forces shot and fired to a group of kolbars (border porters) along the Sheno and Sidakan boundaries. The shooting resulted to the death of one kolbar and a severe injury to another. The deceased kolbar was identified as Ribar Moradi, a 28 years old who was married and had a child.

A group of political prisoners in Rajai Shahr prison, Saeed Masoori, Zaniyar Moradi, Saeed Shirzad, Arash Sadeghi, Payam Shakiba, Loghman Moradi, and Majid Asadi, in protest to the increase of executions in Iran, called for human rights in a letter to all international societies to try to abolish this inhumane punishment.

The prisoners wrote in their letter that unfortunately, we only have not seen this punishment diminished in Iran over the past 100 years, but it is increasing day by day and is also considered a punishment for political prisoners. As an example, we see that the execution of Ramin Hossein Panahi, a political prisoner has been confirmed by the judicial authorities and can be implemented at any moment. As a few political prisoners in Gohardasht Prison (Karaj), we say that execution is a state murder under any circumstances, and while condemning all death sentences for any reason and in any way, we are calling for the abolition of this inhumane punishment. We also call on all international societies, human rights, and all wakeful consciences not to avoid any efforts to abolish this anti-human sentence. (Herana-June 1, 2018)

Majid Moradi, a Gonabadi Dervish from Abdanan in Ilam province, 37, father of a four years old, and arrested during clashes in Golestan 7th St. in Tehran was sentenced to seven years imprisonment and receiving 75 cable strokes. The decree was issued by branch 26 of Tehran Revolution Court on charges of

"acting against the national security through membership in anti-security sect of Dervishes", Gathering and Collusion against national security", "defying the orders of (security) agents" and "disrupting the public peace and order". (Zamaneh Radio-May 27, 2018)

#### State-run Media Deny a Prisoner Killed with Electric Shocker in City of Birjand



On Dec. 30, 2017 prisoner, Abd AL-Rahman Narooee, clashed with several other prisoners and then was taken to the guards' office. There, he was hit by electric shocker and lost his life. A family member said on condition of anonymity: "Three agents hit Abd AL-Rahman on head and chest by electric shocker which led to his death." Amjad Hossein Panahi, a human rights activist, spoke of violent clashes done on his brother, Afshin Hossein Panahi, at the Sanandaj Central Prison. He stated that a few days ago, Afshin was beaten by a person called Abbasi, the Sanandaj Prison's defense officer. Signs of beatings and poundings were seen on the prisoner's body as he

had a family visit in prison.

Amjad also stated that his other brother, Ramin is suffering from kidney pain and infection, and that the prison security authorities are deterring the treatment of the prisoner saying that he will be executed soon and there is no need for him to receive treatment.

Ramin Hossein Panahi was arrested on June 23, 2017 and transferred to Sanandaj Central Prison after 200 days being tortured and kept in solitary confinement. The political prisoner was sentenced to death on January 15, 2018 and the verdict was reaffirmed on April 11, 2018 at Branch 39 of the country's Supreme Court in the city of Qom. # The Deputy of the Chief Judicial Officer: Physical punishments are far more effective than imprisonment

Hadi Sadeghi, Deputy Chancellor of the Judiciary, said: "There is no principle of imprisonment in Islam, so we need to seek for alternative punishments. Physical punishment is much more effective than imprisonment, and the punishment for flogging is much more effective in Islam. But, the human rights agencies do not have a good idea on this matter". He added: "The law allows our judges to issue a prison sentence, but our instructors must think and find alternative sentences. Of course, in the new Islamic Penal Code, judges are allowed to use alternative sentences of imprisonment, but the punishments do not include dangerous prisoners". (ISNA's News Agency- May 30, 2018)

Khadijeh Pak Zamir, wife of Mohammad Habibi, a detainee teacher, assumed about the latest condition of her husband's imprisonment. She said that while visiting her husband in prison on May 27, he was suffering from abnormal pain and the medicines he is using doesn't have any benefits on his condition. She added that the prison authorities have taken no steps to treat the prisoner outside the prison's clinic.

Khadijeh also mentioned that the bail of her husband's freedom was not accepted by the judicial authorities, and she has been protesting this and is still waiting for the answer to be given to her. (Shahrdar Online state-run Website- May 28, 2018)

The condition of the political prisoner, Arash Sadeghi, who is infected with ulcerous colitis or ulcerative colitis, is in a horrible situation and the prison officials have not taken any measures to give him treatments. Although the doctors have warned that the prisoner is in the risk of cancer, the prison guards do not allow him to be transferred to health centers. His digestive problems arose after a long-term hunger strike in 2016, and has become more serious due to the authorities' disagreements for receiving

treatment. It has been said that Arash Sadeghi is in need of a healthy diet, but the quality of Rajai's Prison's food is horrible, and this has increased his digestive problems. He has been deprived from treatment for more than a year, and the security officials refuse to admit him in a hospital. (Sahba News- May 30, 2018)

Farangis Mazlum, mother of Sohail Arabi, said in an interview that since her son is on a hunger strike to protest the prison's condition, he has been banded from any visitation. She added that the authorities of the Great Tehran Prison tried to force the prisoner to write a handwritten note in which it indicates he is

responsible for any consequences willing to happen to him during the hunger strike. Farangis also stated that this week, as usual, she along Sohail's sister left a full day going from Tehran to Varamin to visit Sohail in prison. The prison officer told them he has been deployed to the hospital, and after asking for the hospital's number to go there, the officers they were told after 2-3 hours that they are not allowed to visit or see Sohail due to a fight that he was involved in. So they returned home with concerns.

Sohail Arabi has been arrested since November 2013 and detained in Evin Prison in Tehran, Rajai Shahr Prison in Karaj, and in the Central Prison of Tehran for publishing his own beliefs on his Facebook. (Iran Human Rights Campaign - May 29, 2018)

#### Lack of treatment resulted in the death of a prisoner

A 40 years old prisoner, named Gholam Nabi Rigi, who was sentenced to death, died in Zahedan Central Prison due to lack of timely medical treatment. An informed source said that Gholam Nabi Rigi was kept in Zahedan Central Prison for about 8 months. Yesterday at one o'clock in the afternoon, he suffered a seizure and was transferred to the prison's clinic.

The clinic doctor after examining the prisoner, prescribes that he is in serious condition and should be transferred to the medical centers outside the prison.

But before his transfer and arrival to the hospital, Khosravi, the Prison Director and Sadegh Movadi, the Secretary of the Judge, in charge of the prison, prevented his referral and mentioned that the prisoner is falsifying his illness and the reason of his serious condition is due to the use of narcotics. Hamid Reza Amini, director of a telegram channel, who has been detained in prison since December 02, 2017 was sentenced by the Branch 57 of the Culture and Media Court to pay 95 dollars in cash for charges of publishing lies to disturb public opinion.

Mohammad Hossein Aghasi, the lawyer of Hamid Reza Amini, while confirming the report, said that the

investigations of other charges against Amini will continue in two other courts, the Islamic Revolutionary Court and the General Court.

The prisoner was also on hunger strike for five days since February 17 last year, following his illegal transfer from Evin Prison to Fashafiyeh Prison.

Hamid Reza Amini was arrested by the security forces on December 02, 2017, and transferred to Evin Prison, Section 2, associated to the IRGC (Islamic Revolutionary Guard Corps). The forces also detained his personal belongings at his home, such as his cell phone and computer. (Herna-May 30, 2018)

#### Seventy five percent in Sistan and Baluchistan are in food poverty

According to the representative of the parliament, the people do not have bread to eat, healthy water to drink, and live in an unfavorable situation that you may think of from any points of view.

The debate over the livelihoods of the people in this province was followed after a few days ago in which, Hassan

Shamshadi, a journalist of IRIB with a post on his Instagram page, published a photo mentioning: "What you see here is the food of a family. What do you think the food they are eating, contents? This family and many other families are eating cat's meat".

Based on the official statistics of state institutions, Sistan and Baluchestan province is considered to be the most undeveloped region of Iran in terms of economic and social indicators. More than 60% of the urban population of Sistan and Baluchestan is facing water stress, and close to 1,400 villages in this province are requesting to be supplied with water tankers. The thirty percent dryness of the wetlands is different. For example, in Gavkhoni, about 90 percent, Urmia wetland about 70 percent, and Gandoman wetland about 20 percent have been dried. Abbas Jafari Dowlatabadi, Tehran's Prosecutor, has issued a conviction for the Gonabadi dervishes. He mentioned that since last week till now, 67 verdicts were issued in which most of them are being sentenced and imprisoned.

Jafari Dowlatabadi also indicated that a total of 126

summonses had been given to the defendants in the January's nationwide protests in which 50% was resulted in the issuance of sentences.

In a coordinated raid on February 19 and 20 2017, police and plain clothes attacked dervish protesters whom were gathered in a protest of the arrestment of a dervish. Many dervish men and at least 60 dervish women were arrested after being beaten up by firearms, spraying machines, and tear gases. More than 400 men are still in

According to Diyat's headquarters, there are currently around 500 women across the country out of 6,500 female prisoners kept in prison for exposing unintentional crimes. More than 70 percent of them are households and have children. Diyat's staff statistics also shows that the number of female prisoners who have committed unintentional crimes has increased in the country over the past year. The number of these prisoners in 2016 has risen from 100 to 500 in the year 2017. Most of these women do not have a criminal record and they have just been sentenced to prison due to financial problems, economic pressures, and because of their spouses' and relatives' welfares.
